100 truckloads of humanitarian supplies delivered to besieged towns; second meeting of Humanitarian Task Force to take place on 18 February

The second meeting of the Task Force on Humanitarian Access in Syria will take place on 18 February in Geneva, according to a statement issued by the Spokesperson of the special Envoy for Syria. The meeting will be co-chaired by the Special Envoy for Syria Staffan de Mistura, and the Senior Advisor to the Special Envoy Jan Egeland, and will be attended by representatives of the International Syria Support Group (ISSG). The purpose of this meeting is to further take stock of the status of humanitarian access to besieged areas with an initial focus on the locations referred to in the statement of the ISSG last week. Humanitarian access to these areas will be a first step towards full, sustained, and unimpeded access throughout the country, as demanded by Security Council resolutions, the ISSG and international humanitarian law. "Humanitarian delivery is not only important, it is essential," Mr. de Mistura said. "There are now more than 400,000 people living in areas besieged by the Government, by the opposition and by Daesh." He referred to the U.N. humanitarian mission to some besieged locations that started today as a "test for the capability of the UN to deliver humanitarian assistance and for all parties on the ground to allow this to take place, as per the decisions reached last week in Munich." The U.N.'s resident and humanitarian coordinator in Syria, Mr. Yacoub el-Hillo said, "Today, we reached five besieged towns in urgent need of humanitarian assistance. The convoys contained life-saving aid including food, medical supplies and equipment, vaccines, water and sanitation items for almost 100,000 people in need of aid." Praising the courage of dedicated staff on the ground, Mr. Egeland said that "brave humanitarian workers were able to deliver today 100 truckloads of lifesaving aid to besieged areas in Syria. This is hopefully the beginning of the end of Syrian civilians' suffering."

In a statement issued earlier on 17 February, the UN Spokesperson announced that UN and Syrian Arab Red Crescent operations were underway to deliver life-saving humanitarian assistance to over 100,000 people in the besieged areas of Moadamiyeh, Madaya and Zabadani in Rural Damascus; and in Foah and Kafraya in Idleb. UN Special Envoy meets Syrian Foreign Minister in Damascus

Special Envoy for Syria Staffan de Mistura, arrived in Damascus on 16 February and had a meeting with Syrian Foreign Minister Walid Al-Moualem on the need for unhindered humanitarian access to all besieged areas in Syria. Speaking to reporters afterwards, Mr. de Mistura said that the convoys are coordinated by the UN country team and that it is the duty of the Government of Syria to want to reach every Syrian person wherever they are and allow the UN to bring humanitarian aid. http://www.un.org/press/en/db160216.doc.htm

Intra-Syrian talks to resume by 25 February in Geneva

At a press briefing in Geneva on 16 February, interim Director of the UN Information Service, Ahmad Fawzi, said that Special Envoy de Mistura intends to resume the Intra-Syrian talks by 25 February, and earlier if possible. "Mr. de Mistura is trying to convince those with influence over the warring parties to persuade them to come to the table and "stop the madness", he noted.

UN agencies condemn airstrikes against medical facilities and schools

The UN humanitarian agencies condemned the air attacks against medical facilities on 15 February in northern and southern Syria, which reportedly killed more than 45 people and injured dozens of others. Resident and Humanitarian Coordinator in Syria, Yacoub El Hillo, and Regional Humanitarian Coordinator for the Crisis in Syria, Kevin Kennedy, warned that all seven health facilities are now out of service, of which three are permanently closed. Two of the hospitals were supported by the United Nations. On the same day, two schools were also struck in northern Syria. The Humanitarian Coordinators recalled that directing attacks against civilian infrastructures such as medical facilities may amount to a war crime. Palestine refugees in Yarmouk receive aid for the first time in months

For the first time in months, the UN Relief and Works Agency for Palestine refugees (UNRWA) delivered urgently needed humanitarian assistance to the besieged population of the Yarmouk refugee camp, near Damascus. Aid deliveries began on 14 February and continued for three consecutive days. The agency provided some 1,200 food parcels to civilians in the localities of Yalda, Babila, Beit Saharm and Yarmouk. Residents of the besieged communities said their greatest needs include food, access to clean water and health care. UNRWA is coordinating closely with other humanitarian partners and hopes this renewed access, facilitated by the Syrian authorities, will lead to sustained operations in the area.

Security Council receives first report of joint chemical weapons investigation body

The Secretary-General submitted the first report of the Organization for the Prohibition of Chemical Weapons (OPCW)–UN Joint Investigative Mechanism to the Security Council on 12 February, in line with resolution 2235 (2015). The report provides an overview of the work of the Mechanism, including a review of incidents where the OPCW-UN fact finding missions determined that chemicals were used or likely used as weapons in Syria and identifies potential cases for further investigation. In submitting the report, the Secretary-General reminded that full cooperation from the Government and all parties in Syria remains essential to enable the Mechanism to carry out its mandate. The Security Council is expected to examine the report on 22 February.

Senior UN rights Advisers sound alarm on lack of protections of civilians

The Special Adviser of the Secretary-General on the Prevention of Genocide, Adama Dieng, and the Special Adviser of the Secretary-General on the Responsibility to Protect, Jennifer Welsh, expressed alarm at the deepening humanitarian emergency and lack of protection of civilians in Syria. "Civilian populations in Syria are in a dire situation and in desperate need of protection," the Special Advisers said in a statement on 12 January. "They are subjected on a daily basis to indiscriminate air strikes, deliberate starvation, denial of medical care, enforced disappearance, arbitrary detention and torture. These acts must stop immediately", they stressed. While welcoming the ISSG members' decision to use their influence to ensure that all parties allow sustained humanitarian access to populations, they urged the group to ensure this is implemented on the ground without delay.

High Commissioner for Human Rights gravely concerned about situation in Aleppo

High Commissioner for Human Rights, Zeid Ra'ad Al Hussein, on 11 February, voiced "utmost alarm at the worsening human rights situation in Aleppo and other parts of Syria. "Shocking violations and abuses are committed on a daily basis", he said, deploring that the warring parties do not appear to care in the slightest way about the death and destruction they are wreaking across the country. "The deliberate starvation of civilians as a method of warfare constitutes a clear violation of international humanitarian law," Zeid said. "The targeting of civilians, including thousands of children, is abhorrent and may amount to war crimes and crimes against humanity. Those responsible for such acts, including under command responsibility, must be brought to justice," he added.
