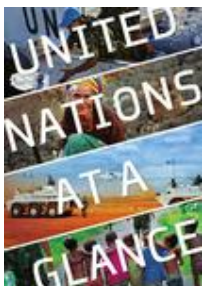

This past year the United Nations Human Rights Council has created new monitoring and reporting mechanisms on the situation of human rights in Syria, Eritrea and Belarus, as well as human rights and the environment, transitional justice and international order. It has also appointed new independent experts for existing mandates. Currently, there are 36 thematic mandates and 12 mandates related to countries and territories, with a total of 72 mandate holders. What are the new mechanisms? Who are the new independent experts? What is their role? And how can you contact them? Answers can be found in this new media guide published by the Office of the United Nations High Commissioner for Human Rights (OHCHR).

A UN investigation into the human rights situation in southern Masisi territory in the North Kivu province of the Democratic Republic of the Congo has revealed that at least 264 civilians, including 83 children, were arbitrarily executed by armed groups in more than 75 attacks on villages between April and September this year. The UN Joint Human Rights Office in the DR Congo (UNJHRO) had received reports of human rights violations during attacks of ethnic

character, part of a conflict with economic and political root causes, targeting mainly civilians in North and South Kivu since the beginning of the year. The attacks intensified from April 2012 in southern Masisi. The UNJHRO led six investigations into these allegations and interviewed more than 160 witnesses as well as local authorities, civil society members, the Congolese national police (PNC) and health care workers. The investigators uncovered mass killings, mass forced displacement and large scale looting and destruction of private property. The UNJHRO also confirmed four cases of sexual violence involving the rape of 12 women. The report makes a series of recommendations, including a call for Congolese security forces, with the support of the international community, to restore security in southern Masisi and ensure the protection of civilians. Congolese authorities are also urged to take into account the violations detailed in the report and the responsibility of the alleged perpetrators when considering Security Sector Reform (SSR) measures and verify the human rights records of any members of armed groups seeking integration into the national army.

On the occasion of Human Rights Day (10 December), the United Nations Office at Geneva (UNOG) Archives have completed a digitization project that provides online access to 35 files containing several thousand pages of original and unique materials related to the drafting of the Universal Declaration of Human Rights. This material includes drafts of the Declaration, comments from governments, organizations and the general public, and material related to the implementation of the Declaration. Original documents from René Cassin and Eleanor Roosevelt are included in these invaluable records.

Delivering emergency aid is a vital contribution of the international humanitarian community in situations where national government capacity is stretched.

Risk Knowledge Fundamentals: Guidelines and Lessons for Establishing and Institutionalizing Disaster Loss Databases (UNDP)

This report documents the experiences of the UNDP Regional Programme on Capacity Building for Sustainable Recovery and Risk Reduction (RP) in implementing disaster loss databases using the DesInventar methodology. The Regional Programme has been established in response to the Indian Ocean tsunami of 2004, and is managed by the UNDP Regional Centre in Bangkok's Crisis Prevention and Recovery Team. DesInventar is based on a relational

database structure and a disciplined expert assisted structure for data collection and classification that permits the homogeneous capture, analysis and graphic representation of information on disaster occurrences and losses. The findings from this review of database implementation concludes that disaster loss databases with validated data and inventories are essential for identifying and tracking patterns of disaster risk, and that they are a fundamental requirement for implementing efficient and effective DRR policies and programmes.
