The United Nations has launched a campaign ahead of its major conference on sustainable development (Rio+20) in June next year, inviting governments, non-governmental organizations (NGOs) and people everywhere to engage in a global conversation about the communities they want to see in the future.



As part of the campaign, the UN is launching a website that will provide information about several key sustainable development issues, including cities, disaster resilience, energy, food, jobs, oceans and water. The website will also serve as an online platform through which the public can send ideas and comments and discuss issues on sustainable development.

This policy guide - released by the UN Office on Drugs and Crime (UNODC) - offers advice on how to reform and improve criminal justice systems so that they are fairer and more sensitive to the needs of victims of terrorism and their families. The publication, the first of its kind, includes advice for policymakers and criminal justice officials and examples of good practices to support victims of terrorism. Recommended measures include judicial assistance, protection from intimidation and retaliation, material, medical, psychological and social assistance and access to compensation.

A new report by the Joint United Nations Programme on HIV/AIDS (UNAIDS), released on 21 November 2011 shows that 2011 was a game changing year for the AIDS response with unprecedented progress in science, political leadership and results. The report also shows that new HIV infections and AIDS-related deaths have fallen to the lowest levels since the peak of the epidemic. New HIV infections were reduced by 21% since 1997, and deaths from AIDS-related illnesses decreased by 21% since 2005.

Doing Business 2012 is the ninth in a series of annual reports investigating the regulations that enhance business activity and those that constrain it. Doing Business presents quantitative indicators on business regulation and the protection of property rights that can be compared across 183 economies—from Afghanistan to Zimbabwe—and over time.

Estimating illicit financial flows resulting from drug trafficking and other transnational organized crime (UNODC)

Criminals may have laundered around \$1.6 trillion in 2009, one fifth of that coming from the illicit drug trade, according to a new report by the United Nations Office on Drugs and Crime (UNODC). The \$1.6 trillion represents 2.7 per cent of global gross domestic product (GDP) in 2009, says the agency. This figure is in line with the range of two to five per cent of global GDP previously established by the International Monetary Fund (IMF) to estimate the scale of money-laundering. The report also says that the "interception rate" for anti-money-laundering efforts at the global level remains low.

The report says an estimated 5.1 billion people lack adequate social security or social protection worldwide. The floor is based on the idea that everyone should have basic income security sufficient to live, such as pensions for the elderly and persons with disabilities, child benefits, income support benefits and/or employment guarantees and services for the unemployed and working poor.

State of World Population 2011: People and Possibilities in a World of 7 Billion (UNFPA)

The report looks at the dynamics behind the numbers. It explains the trends that are defining our world of 7 billion. Today, 893 million people are 60 or older. By the middle of this century that number will nearly triple, to reach 2.4 billion. About one in two people now lives in an urban area. In about 35 years, two out of three will. People are living longer. Today's average life span is 68 years, compared to 48 in 1950.

Judicial and law enforcement officials are so far implementing sporadically the two-year-old law supporting the equality and rights of Afghan women, and the Government has not yet succeeded in applying the law to the vast majority of cases of violence against women, the United Nations Assistance Mission to Afghanistan (UNAMA) and the United Nations High Commissioner for Human Rights said in a report released on 23 November 2011.

Developed by the United Nations Environment Programme (UNEP) and Groupe URD, with support from the Flemish International Cooperation Agency, the training consists of 11 modules which cover topics ranging from key environmental concepts and solutions for sustainable logistics to waste management in emergency situations and alternative energy sources.

Proceeds from the book will support UNHCR in developing libraries in refugee camps in Eastern Chad where an estimated 285,000 Sudanese refugees live.
