This Policy Guide seeks to enhance the ability of policy makers and practitioners – in governments, regional and international organizations, and civil society – in strengthening their efforts to protect civilians from conflict-related grave harm and mass atrocity crimes. The Guide clarifies and compares the twin of the Responsibility to Protect (R2P) and the Protection of Civilians (POC) in their normative, institutional and operational dimensions, distinguishes the principles' different actors and methods, and specifies the situations when the two principles converge for specific actors and organizations.

The Departments of Peacekeeping Operations (DPKO) and of Field Support (DFS) recently released a Manual for UN Infantry Battalions serving in peacekeeping missions. Spearheaded by the Office of Military Affairs (OMA), the United Nations Infantry Battalion Manual (UNIBAM) aims to improve United Nations military peacekeepers’ performance. It outlines standards, tasks, structures, equipment requirements, and self-evaluation tools for infantry components in United Nations peacekeeping operations. The concept for the UNIBAM originated as part of a comprehensive agenda for peacekeeping capability development under the “New Horizon” reform process. It is part of DPKO/DFS efforts to put in place an enhanced performance management. The document was developed with inputs from Member States, former battalion commanders, peacekeeping practitioners, training experts, field missions and United Nations system partners.

### **Afghanistan Opium Survey 2012: Summary Findings (UNODC)**

Despite significant eradication efforts, high opium prices led to an increase in poppy cultivation in Afghanistan this year. Cultivation was 18 per cent higher this year than it was last year, covering 154,000 hectares. However, since plant diseases and bad weather had damaged crops, potential opium production fell 36 per cent over the same period from 5,800 to 3,700 tons.

The report shows that a more than 50% reduction in the rate of new HIV infections has been achieved across 25 low- and middle-income countries--more than half in Africa. HIV infections have been cut dramatically by 73% in Malawi, 71% in Botswana, 68% in Namibia, 58% in Zambia, 50% in Zimbabwe and 41% in South Africa and Swaziland.

### **Fisheries and the right to food – Report to the General Assembly (A/67/268)**

The United Nations Special Rapporteur on the right to food, Olivier De Schutter, warned on 30 October 2012 of the threat of 'ocean-grabbing' to food security, and urged world governments and international bodies to halt the depletion of fish stocks, and take urgent steps to protect, sustain, and share the benefits of fisheries and marine environments. "'Ocean-grabbing' – in the shape of shady access agreements that harm small-scale fishers, unreported catch, incursions into protected waters, and the diversion of resources away from local populations - can be as serious a threat as 'land-grabbing,'" Mr. De Schutter said as he unveiled this new report.
